## EVENT THAT MARKED THE PREVIOUS PERIOD



#### 20 JUNE 2017

### MONTENEGRO OPENED CHAPTERS 1 AND 22 AND TEMPORARILY CLOSED CHAPTER 30

At the Intergovernmental Conference in Luxembourg, Montenegro has opened two new negotiating chapters, Chapter 1 – Free Movement of Goods and Chapter 22 – Regional Policy and Coordination of Structural Instruments, and has temporarily closed Chapter 30 – External Relations.

It is jointly assessed that, by completing the final benchmarks and closing the chapters in the field of external relations, Montenegro is starting a new phase of the negotiation process. The perseverance of pro-European politics and the continuity of reforms has been commended, as a result of which Montenegro, after five years of negotiations, has opened 28 out of 33 negotiating chapters, the negotiations of which are being conducted, and has temporarily closed three of them.

## CONFERENCES, REGIONAL AND INTERNATIONAL MEETINGS

### 25 JANUARY 2017

### REGIONAL CONFERENCE HELD ON "EC REPORTS – ACCESSION REFORMS OF WESTERN BALKANS"



Conference was opened by Mr Aleksandar Andrija Pejović, Minister of European Affairs and Mr Hans Ginter Matern, Ambassador of Germany to Montenegro. Participants of the Conference exchanged

views on this year's EC report estimates for the countries in

the region, further commitments from the accession process, as well as the expectations of the upcoming Summit of the Berlin process, which would be held under the Italian Presidency over the Initiative. Minister Pejović pointed out that the Berlin process has provided many new ideas and opportunities to the regional perspective, and that EC reports proved to be a good tool for candidate countries in the process of accession regarding the readiness of taking over future membership commitments.

### 15 MARCH 2017

# CONFERENCE HELD ON "TRANSLATION OF THE EU ACQUIS, MONTENEGRIN LEGISLATION AND OTHER EU-ACCESSION RELATED DOCUMENTS"



Significance and results of the project were presented by Mr Aleksandar Andrija Pejović, Minister of European Affairs, Mr Aivo Orav, Head

of the EU Delegation to Montenegro and Ms Valentina Šćekić, project coordinator from the Educo Center. Minister Pejović pointed out that in the framework of the project "Translation of the EU acquis, Montenegrin legislation and other EU-accession related documents", we have translated 17,000 pages of the Acquis and documents from the negotiation process. He said that the Ministry of European Affairs was starting to implement the second, much more extensive cycle of translating the EU acquis into the Montenegrin language as of the following week, which was expected to encompass translating 30,000 pages of EU regulations within a year, pointing out that the plan was to have a quarter of the EU acquis translated into Montenegrin by June 2018.

# CONFERENCE ORGANISED ON "SIXTY YEARS AFTER THE TREATIES OF ROME: FURTHER PATH OF EUROPE"



On the occasion of the 60th anniversary of the signing of the Treaties of Rome, the Ministry of European Affairs of Montenegro, in cooperation

with the Embassy of Italy and the Delegation of the Eu-

ropean Union, with the support of the EU funded technical assistance project "Strengthening the Capacities of the Montenegrin Authorities for the EU Accession Process and IPA II Instrument", organised the Conference "Sixty Years After the Treaties of Rome: further path of Europe".

The conference was opened by Mr Aleksandar Andrija Pejović, Minister of European Affairs and Mr Carlo Lo Cascio, First Deputy Director General of the DG for the European Union of the Ministry of Foreign Affairs and International Cooperation of Italy.

Within the two panels, where representatives of governments, parliaments and the civil sector of Montenegro, Italy, Bosnia and Herzegovina and Serbia spoke, there was the discussion on the Treaties of Rome and their importance for the development of the idea of a united Europe, as well as the future of the EU and the enlargement policy.

Croatian Parliament, Mr Joško Klisović and Croatian Ambassador to Montenegro, Mr Veselko Grubišić, spoke about the importance and achievements of cooperation in the process of accession to the European Union.

Minister Pejović pointed out that experiences of colleagues from Croatia were very important for the institutions and negotiating structure of Montenegro, and that they have helped to fulfill the obligations in a significant number of areas in a better way.

On the occasion of marking five years since the official beginning of the accession negotiations, the Ministry of European Affairs of Montenegro organised the Conference "Five years of accession negotiations

- what we have accomplished". The Conference was opened by Mr Aleksandar Andrija Pejović, Minister of European Affairs of Montenegro, and Mr Aivo Orav, Head of the EU Delegation to Montenegro. Minister Pejović pointed out that the number of people and institutions involved in the negotiations was the best indicator of the scope of the process and how significant it has been for Montenegro. He also said that the last five years have been a period of important and fundamental changes for Montenegro, thanks to which we had made an enormous step forward.

In his opening remarks, Minister Pejović pointed out that the assessment of Montenegro's progress was based primarily on the quality of implementation of the measures set out in the action plans for chapters 23 and 24, stressing that their implementation has been largely running as planned. He said that the high level of implementation of these strategic documents has been noted, and added that the implementation of measures over the past period has resulted in notable reforms in the legislative area, their implementation and institution-building, stressing that the future work in the field of the rule of law would be very intense as well.

his opening remarks, Mr Aleksandar Andrija Pejović, Minister of European Affairs, recalled that since the beginning of the negotiation process, Montenegro has made significant progress in the areas covered by this Subcommittee, which was confirmed by the fact that negotiations on Chapter 4 – Free Movement of Capital, Chapter 5 – Public Procurement, Chapter 6 – Commercial Law, Chapter 7 – Intellectual Property Law, Chapter 9 – Financial Services, and Chapter 28 – Consumer and Health Protection have been opened.

Negotiations opened in Budva the Ninth meeting of the Civil Society Joint Consultative Committee (JCC) between the European Economic and Social Committee and Montenegro.

Minister stressed the importance of civil sector participation in the negotiations, highlighting their contribution to the work of working groups, as well as to the preparation of documents crucial for the negotiation process. In this context, he pointed out that meetings of the Joint Consultative Committee have been valuable contribution to the affirmation of cooperation between state authorities and the civil sector, as well as the support of the civil sector to the accession process.

### EU RULE OF LAW EXPERT MISSION IN MONTENEGRO COMPLETED



The final meeting of the EC expert mission on combating corruption and organised crime was held in Podgorica, which stayed in Montenegro from 30 January. During their visit to Montenegro, independent experts from Italy and Belgium had meetings with representatives of the Ministry of Justice, Ministry of Interior, Police Administration, Public Prosecution Office and Judiciary, Public Property Administration, Administration for Prevention of Money Laundering and Financing Terrorism, Agency for Prevention of Corruption, Centre for Judicial Training and the Central Bank of Montenegro.

### EU RULE OF LAW EXPERT MISSION IN MONTENEGRO COMPLETED



Expert mission led by an expert from Italy visited Montenegro in the period 3-7 April, in order to assess the progress in the functioning of this institution by direct insight into

its work, as well as by adding to the recommendations given after last year's mission related to this area.

During her stay in Montenegro, the expert met with the representatives of the Ministry for Human and Minority Rights, Ministry of Labour and Social Welfare, Ministry of Sustainable Development and Tourism, Ministry of Education, Committee for Human Rights and Freedoms of the Parliament of Montenegro, Fund for Protection and Exercising of Minority Rights, Centre for Preservation and Development of Culture of Minorities, as well as national minority councils.

# EU RULE OF LAW EXPERT MISSION IN MONTENEGRO COMPLETED

The final meeting of the EC expert mission was held in Podgorica, which was dedicated to assessing the fulfillment of provisional measures related to the area of prevention of corruption from Chapter 23, for the implementation of which the Agency for Prevention of Corruption has been in charge. The mission, which

stayed in Montenegro from 5 to 9 June, in order to assess the progress in this area, was led by Slovenian and Latvian experts, who had on this occasion a series of meetings with representatives of the Agency for Prevention of Corruption and representatives of the State Audit Institution.

Addressing the conference participants, Ms Ivana Glišević Đurović, Acting Director General for European Funds of the Ministry of European Affairs, reminded that successful cooperation of the three countries has been continued with the new program, which have jointly implemented 78 projects of total value in the previous seven-year period of EUR 250 million, through the Adriatic Cross-Border Program and two transnational programs - Southeast Europe and the Mediterranean Programme. She added that these projects have enhanced the activities in the field of culture, tourism, transport, energy efficiency, environment protection, as well as competitiveness and entrepreneurship, and it has been expected that the cooperation of the three countries would be further developed through partnerships within the new trilateral program, with the total budget of EUR 93 million, including co-financing.

He emphasised that the projects contributed significantly to the realisation of specific program goals, including the economic development of the program area, protection of its biodiversity and promotion of sustainable use of natural resources, with particular emphasis on the agriculture and forestry sector and the sector of development of tourism.

Within the 2nd Call for the 2014-2020 Interreg Danube Co-operation Programme, which will be opened in May this year, EUR 60 million will be allocated for projects



aimed at strengthening transnational cooperation between regions and participating countries, primarily in the areas of innovative and socially accountable action, ecological and cultural activities and a better integrated and energy-responsible region, Mr Aleksandar Andrija Pejović, Minister of European Affairs, said in his opening remarks. He reminded that the Danube Transnational Programme supported the transnational cooperation of partners from countries, i.e. the EU region and IPA beneficiary countries, in order to strengthen the competitiveness of the Danube Region, with 114 million inhabitants presently. Nine EU Member States and three IPA beneficiary countries have been participating in the Programme, including Montenegro, Serbia and Bosnia and Herzegovina, as well as two beneficiary countries of the European Neighborhood Instrument, Ukraine and Moldova.
